Motion: Mr. Jones motioned to nominate Mr. Shafer as Vice-Mayor. Mrs. Keller motioned to nominate Mr. Hellinger as Vice-Mayor. Mr. Shulman closed the nominations. Mr. Shafer and Mr. Hellinger accepted the nominations. Motion approved with Mr. Shafer designated as Vice-Mayor with a 4-3 (Hellinger, Keller, Farrell) vote.


